DRAFT BOARD SET FOR REGISTRATION

Widespread Economies As School Board Plans Preliminary Budget

At its regular monthly meeting on Feb. 9, the board of education made a preliminary study and recommendations to the superintendent regarding the planning of the budget for 1942-1943.

The board, accordingly, set two major limitations upon the budget for the coming year:

(1)—That the present millage of 1941-1942 should be held to if possible, even though vote of taxpayers in September, 1941, authorized the increase of one-half mill for the 12-room addition to the Mason school.

(2)—That the present high standards of education in Grosse Pointe should not be sacrificed to war conditions, but that economies should be effected by strict conservation, where possible.

The first step in this direction was to vote to issue only \$200,000 of the approved \$300,000 Mason bond issue at the present time.

At the total cost of the structure approval of the State loan board for the full amount of \$300,000 will be sought in the case of unforeseen emergencies, although only \$200,000 will be paid at this time.

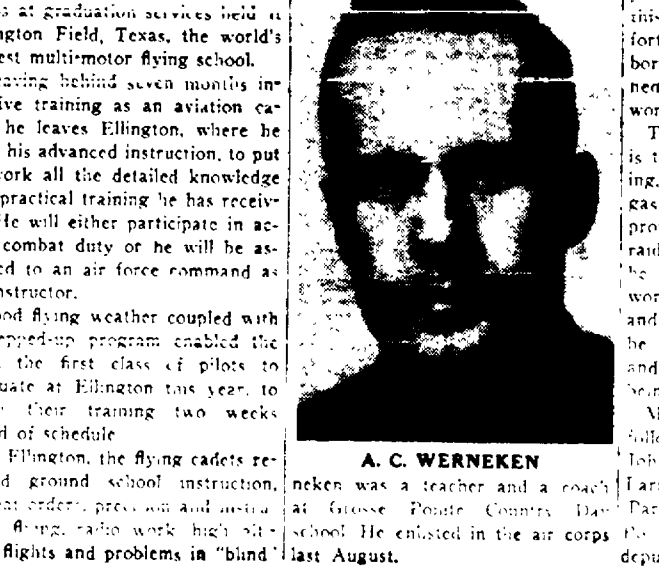
At the time the plan of the building as proposed will be submitted to the State Board of Education through the Michigan State Board of Control.

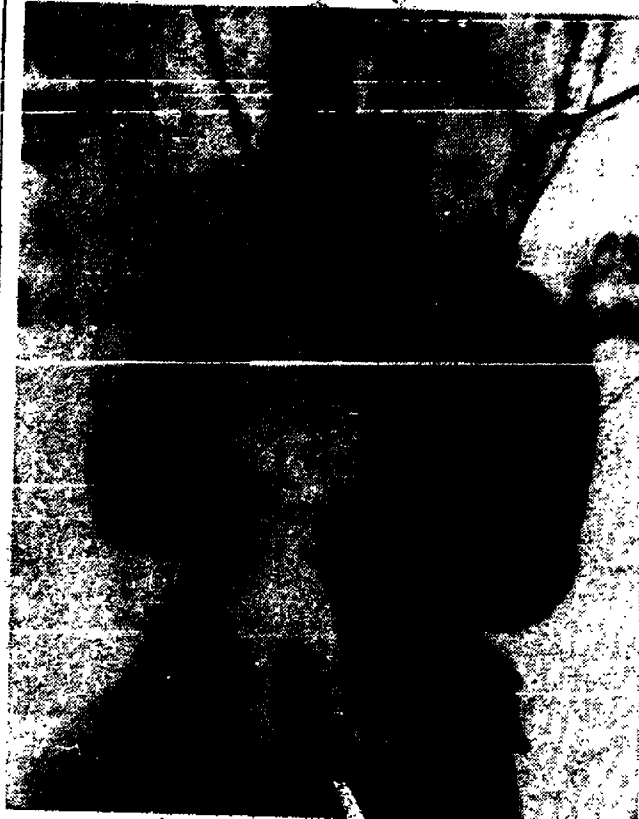

Three locations have been set for Monday's registration: At the Grosse Pointe Park Municipal building; at the annex to the municipal building in the City of Grosse Pointe, 17140 Marmec; and at the Grosse Pointe Farms municipal building, 90 Kerby road. Registrations will begin at 7 a.m.

Early registrations may also be made now during the regular office hours at the draft headquarters in the Park municipal building, officials said. Cards and other equipment have been received and any man desiring to register during this week may do so.

Finally, Claire promises a clean, honest and efficient administration.

Claire carries the endorsement of both the UAW-CIO and Labor's Non-Partisan League.

Heated Debate Occurs as Candidates Present Political Pleas Sunday

A packed audience heard the political affairs of Gratiot township brought out in the open and discussed in heated detail Sunday afternoon when the candidates for the various jobs open in the primary election Monday, Feb. 16, responded to the invitation of the Civic League to present their political programs.

The speeches of the two candidates for the top job of township supervisor, Odilon Houtekier, incumbent, and Eugene Piornack, highlighted the discussion. The two persistent problems of the tax situation in the township and the organization and operation of the water board received primary attention.

In explaining the tax situation,



Piornack went back to last year's campaign promise of the present supervisor, Houtekier, who came out with a platform which stated that he and he alone, if elected, would determine the tax assessments. To prove that Houtekier was bound by the 10-point program, in which the tax clause was included, Houtekier quoted from a publication then circulated in the township, which said: "Odie Houtekier, candidate for the office of supervisor, — not only subscribes to the 10 important planks in the committee's platform, but actually assisted in the drafting of them."

However, when the time for tax assessments came, Houtekier not only brought in county tax authorities, but in a number of cases even saw to it that the assessments were raised from 15 to 25 per cent, Piornack charged.

The present situation whereby three members of the township board, a majority of that board, now compose the water board also came in for Piornack's censure. Under the present setup, he charged, the members of the water board meet, in secret, make a decision, and carry the majority vote when the problem comes up before the township board. Instead of the present setup, Piornack recommended that the water board be composed of civilian users, to keep that board from being used as a political football.

In reference to the accusation that he had been greedy in demanding payment of \$150 per month while he was director of the water board, Piornack showed that the salary had been based on a wage of \$125 per hour of time actually spent and for the use of his car. That this much time could easily be spent on the job became evident when Piornack explained the many duties of the job, which included not only inspections but the actual transfer of the water system from that of Detroit to the township, the setting up of the books, which, incidentally, stood up 13 months without an audit and drew the praise of Detroit auditors.

Houtekier, in answer to Piornack's statements, admitted that he had asked the Wayne county officials to help him with the tax rolls, explaining that "he wanted expert advice," despite his campaign promise.

In attempting to refute the fact that the water board is packed with township officials, including himself, Houtekier said that it was designed as an "economy measure" as an attempt to avoid duplication of work. He followed this with the suggestion that regular civilian users were not qualified to make decisions on problems met by the water board.

Gratiot East Park Manor Residents to Pay \$1.00 per Month Water Service Charge - HOUTEKIER

Within a month after Odilon Houtekier assumed the duties of supervisor, he announced that the residents of East Park Manor would have to pay \$1.00 per month service charge on their water, because a group of real estate interests wanted a trunk line down Harper to enhance the value of their vacant property.

The only member of the township board who disagreed with Mr. Houtekier's wishes was Eugene C. Piornack, the township clerk, and at present a candidate for the office of supervisor. Piornack stated at that time and still states that East Park Manor residents should not have to pay \$1.00 per month service charge, and that the residents in the balance of the township should only pay 50 cents per month, instead of the \$1.00 they are forced to pay at the present time.

According to an ad in a newspaper of last week, Houtekier was supposed to have been endorsed by the Gratiot Citizens Committee, who disbanded last May, and according to their president, have never held a meeting since, with the single exception of the meeting hastily called for last Tuesday night.

Promise No. 4 of Houtekier's platform of last year stated the people would be masters of the affairs, but at the present time the people can't even find out about the affairs of the township. It was recalled that in Houtekier's campaign of last year he stated the records were out of order and asked for an audit.

Besides breaking the promises of his campaign, Mr. Houtekier has attempted to become a dictator by obtaining from the board the right to hire and fire as he pleases. Mr. Houtekier set up a three-man water board and appointed himself chairman at a fixed monthly salary.

On top of this, they have padded the water fund to the extent of about \$2,600 by placing into it \$1,800 of plumbing permit money, and about \$800 received from forcing new residents to put up \$5.00 guarantee for payment of their water bill.

Mr. Houtekier has as his running mate another individual who is likewise endorsed by a non-existing group, namely Lloyd Lyle, candidate for the office of clerk and present secretary of the school board, whom the residents of District No. 2 will remember, for as soon as he took office he discarded the wishes of the people who had voted three times to select a school site.

Mr. Lyle is opposed for the office of clerk by Al Claire, who is president of the East Park Manor Civic League and, like Piornack, is a working man carrying a union card, and is endorsed by Labor's Non-Partisan League.

Piornack was a sergeant in the United States Army during the World War.

The last legislature in the anticipated law that the schools received in loss of \$62,750 in revenue from a redistribution of state aid. As the receipts of this state aid have come in during the year, it is apparent

that the losses of Grosse Pointe schools will not be as great as anticipated. It was thought at the time of planning the present budget that the reduction might be even greater. The amount of increase of state aid over the anticipated budget of this item will be sufficient to make the necessary restoration of the 1930-1932 salary schedule without any increase in taxation, and to provide a modest cost of living adjustment for employees receiving less than the master's degree maximum during the remainder of the present budget year. The board accordingly approved these adjustments of salaries.

Although costs of supplies, fuel and textbooks are increasing, a schedule of economics were presented to the board by the superintendent and his staff which will

probably offset a part of these increases. Further economies in transportation will be possible by the elimination of free transportation of almost 175 children to the Defer and Vernier schools who will attend the Mason school when the addition is completed in August. The cost of transporting pupils is approximately \$20 a year for each pupil and a savings of approximately \$3,000 is anticipated here.

Other allowances which had to be made in the 1941-1942 budget for remodeling various elementary schools to take care of increased numbers can be eliminated from the new budget of 1942-1943. During this past budget year approximately \$25,000 had to be included for these purposes which will not have to be budgeted in 1942-1943.

In general, the plant and building needs of the district are, with the new Industrial Arts building at the high school, the addition of 12 new classrooms at Mason school and some anticipated alterations in other schools, relatively adequate for the coming year.

This, together with economies which have been mentioned and others which the board is working out, will permit a high standard of education in Grosse Pointe during 1942-1943 without increasing the local school tax, unless something unforeseen might happen to decrease assessed valuation.
