

Durant Discusses Taft-Hartley Act With Members of Union

Before a group of both CIO and U. M. W. members, Richard Durant, Republican candidate for Congress from the 12th District on the Republican ticket, last night discussed the Taft-Hartley Act. Durant, an overseas veteran of World War I, declared that the Act failed to get to the root of our real troubles.

Earlier in the evening Durant discussed hidden taxes and foreign policy. A question was raised from audience about his opinion on the Taft-Hartley Act—be for it or against it?

Replying that he was delighted at the question had been raised, Durant suggested that it would be an excellent idea to talk over what things should be in an act.

"Let's forget about what may or may not be on the books—let's decide what things would like to write into the act if we were down in Washington."

He then went on to ask for a list of hands among his audience—how many of them thought Communist should be allowed to hold offices in unions? Noting that raised hands, Durant remarked: "Good. We're in complete agreement. Any good labor should have some means of organizing in unions."

Durant and the large majority of his audience were also in complete agreement that union members should have the right to know where their money was going; that anyone who broke a contract into which he had freely entered should be liable for damages; that free speech for every member, provided no threats were made, was a good thing and something to be preserved; that no one should have the power to sack an employee; that unions should be established through democratic procedures; and that nobody but the government, when it levies taxes, should have the power to deduct anything from a man's paycheck without his permission.

Now that we've finished our discussion," said Durant, "will anybody tell me what all the shouting about the Taft-Hartley Act is all about? Every point that I have agreed would be a good thing—every point we need should be in a labor law—in the Taft-Hartley Act."

The fact is that the guys who shouting the loudest about it's a 'slave labor' law are the ones who have their thumbs in the back of your necks. And because the Act has released the pressure from you a little, and made you a little more free, they'll thank you. But for us in rank and file, it's a save labor law."

Durant, who has frequently been mentioned during his campaign that he intended to state his convictions openly whether they were popular or not, then

then went on to point out that the Taft-Hartley Act failed to go to the real root of the trouble today.

"We can't blink the fact any longer," he declared; "a good many of the big unions today are absolute monopolies, as bad as anything Rockefeller or Morgan ever did in their time. Unions today are the only organizations exempt from the anti-trust laws. And as every one of us knows, it has gotten to the point where one man, or one small group of men, can close down entire industries, cripple the nation, bring suffering on the public, and force their union members to take action which may be dead set against their wishes."

"This country was built on the principle that every man should be equal before the law, that no one was entitled to special privileges denied everybody else. To allow certain unions unrestricted powers denies that principle."

"Moreover, the situation is made even worse by the fact that you and I are helpless when one of these union bosses wants to knock us around. Do you remember the coal strike of last winter? And do you remember the steel strike of last year?"

"That steel strike was about pensions. And then the strike was over—after nearly crippling the country—the employees of Inland Steel Corporation were asked to vote on whether they wanted the pension plan they had won by that three month strike, or did they prefer the company's old pension plan—the plan they had had for eight or nine years. All the men—13,000 of them—voted 3 to 1 in favor of the old pension plan."

"When the vote was announced, reporters went to the local officials, asking why, if they felt that way about the old plan, had they gone out on strike? What was the sense of it? And the union officials replied, 'We had no choice. The way our set-up goes, when we get the word from Mr. Murray and his lieutenants—we have to go out, whether we want to or not.'"

"Does anyone," Durant wanted to know, "think that sort of thing is right? I say it's time for a little honesty on this subject. I say every man should be equal before the law—I say that every union member should be free from the fear of violence for speaking his mind. And that's why I want to be your Congressman."

Kelly Greeted By Crowds On Michigan Tour

Former Governor Harry F. Kelly, candidate for the Republican nomination for Governor, this week began a swing through the western and southwestern sections of Michigan.

Last week he completed a preliminary tour of the Upper Peninsula, being greeted by large and highly enthusiastic crowds at every appearance.

He spoke at dinner meetings in Hancock and Marquette, a luncheon of the Michigan Sheriffs Association at Escanada and a Kelly-for-Governor Club rally at Sault Ste. Marie. In each appearance, with the exception of the sheriffs' meeting he made radio addresses.

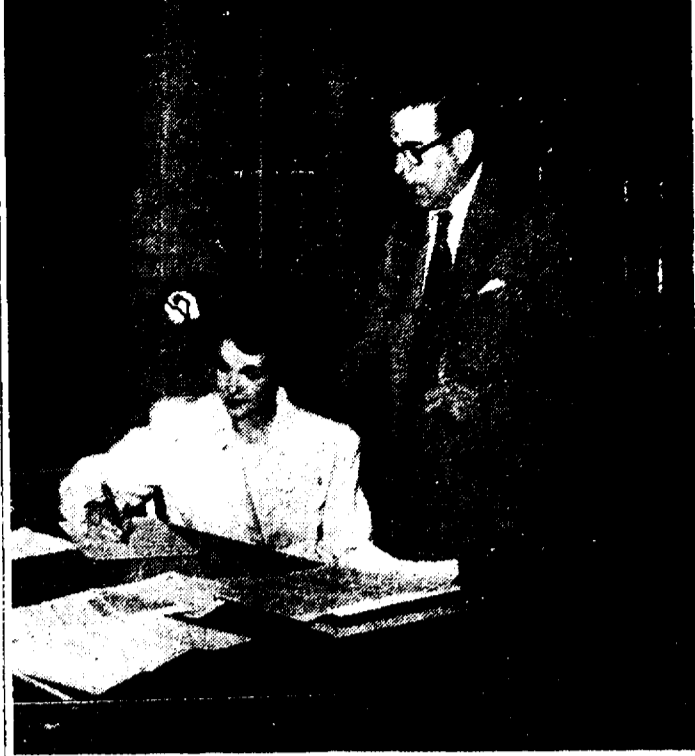
Mr. Kelly emphasized the necessity for unrelenting attack on the Communist party, communists and sympathizers; demanded an end to government waste and deficit spending; a state policy considering labor, management and public equally in all labor-management issues.

He also demanded a fast step-up in development of tourist and resort areas and facilities, highways and bridges. He blasted away at Fair Dealers for attempting to show the Republican Party in Michigan is indifferent to humanitarian needs. He said that the official records of his administrations showed a progressive policy of legislation on human needs that won nationwide recognition and acclaim.

Calling the "economic danger from inflation as serious as the military danger of an armed attack on this nation" Rep. Louis C. Rabaut has introduced a resolution in the House of Representatives for an investigation of economic factors affecting the cost of living of moderate and middle-income families.

In the preamble to the resolution Rabaut said, "... the challenge to free institutions and world peace by Communist aggression in Korea is being utilized by unscrupulous elements as the basis for drastic price rises in food, clothing, household goods, and other cost-of-living items, otherwise economically unwarranted."

Rabaut characterized the present wave of hysterical buying as "just plain silly" and added that "those who rush headlong into this stampede of avarice are helping to bring about just what they fear most, namely drastic controls on the production and distribution of consumer goods."

The Resolution which Rabaut introduced calls for the establishment of a select committee of the House to investigate the effects on the cost of living of factors relating to United States military preparation or operations and the processing and distribution costs and practices with relation to "food and fibers."

"There are no shortages in sight now," said Rabaut, "and barring any drastic changes in the world situation there need be none unless created by panicky or speculative buying far beyond any normal needs."

"Especially contemptible," said the Detroit Congressman, "are those who are using the Korean crisis as a lever to boost prices on the large inventories of consumer goods which they are selfishly acquiring. Our economic stability is the cornerstone of our military strength and such people are understanding the whole structure of national preparedness."

Quoting from President Truman's Midyear Economic Report, Rabaut concluded, "Those of us who are not now called upon to make great sacrifices should certainly, in justice to those who are in the armed services, refrain from hoarding and avarice."

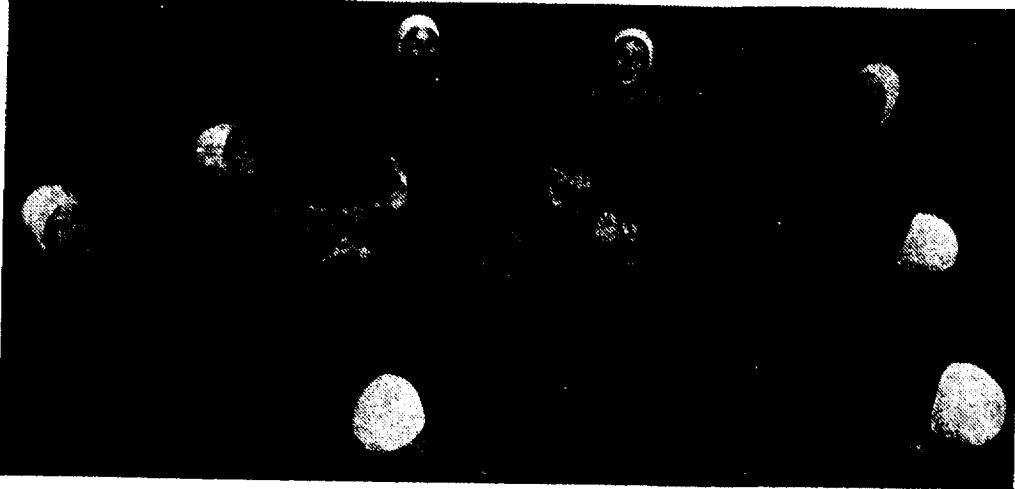

Health Department Issues Advice on Safe Home Canning for Foods

The health department has issued the following advice on safe home canning for foods: 1. Use the type of lid you are using. 2. Keep the pressure cooker's petcock and gauge clean. Have the gauge checked by its manufacturer. 3. Prepare only one load for the cooker at a time. Work quickly. While one load is processing, prepare another. "Two hours from garden to can" is a good rule to follow. Be sure the pressure is completely down before you open the cooker. 4. Cool jars quickly, but out of any possible draft. Don't turn jars upside down—this breaks the seal. Tilt them gently to test for leaks. If vacuum seal lids are used, remove the screw cap the following day to be certain that no inadequately sealed jars are stored. Store in a cool, dry place. 5. Don't try to can the entire crop in one day. Give special care and attention to each step in home canning. Let other work go during canning hours. Pen the small child away from the canning area in the kitchen. Keep a bottle of burn treatment preparation in the kitchen. 6. Review your canning methods in the light of the latest government information on safe canning may save your life, the State Health Department said. Pamphlets containing government recommendations can be obtained from the county agricultural agent's office or from Michigan State College.
