Thursday, August 4 THE HARDEST fought gubernatorial contest in years will begin shortly between Republican candidate Paul D. Bagwell and Democratic Lt. Gov. John B. Swainson, who outlasted his two party foes, Secretary of State James M. Hare and Detroit Councilman Edward Conner, to win the Democratic nomination.

Swainson, 35-year-old protege of Gov. Williams and friend of labor, scored a surprise victory over the other two candidates for the Democratic nomination.


Swainson beat Hare by a margin of over 70,000 votes.

Woods Continues To Be Fastest Growing of Six Municipalities In District

Figures obtained in the annual School Census, taken each May, reveal that the population of the School Pointe School District reached 63,590 in 1960, an increase of 379 persons over 1959.

Grosse Pointe Woods continued to be the fastest growing of the six municipalities involved. (A portion of Harper Woods is cluded in the school district along with the five Pointes.) The Woods showed a gain of 247 persons, going from 18,873 residents to 19,120.

The Park gained 151, ad-vancing from a 1959 total of 15,860 to 16,011 this year. The Farms lost 159, dropping

from 12,782 to 12,569. The City lost 16, going from 6,843 to 6,827.

The Shores gained 104, from 2,197 last year to 2,301 this May.

The section of Harper Woods which is included in the district gained 52 residents, making a total of 6,762 this year as against 6,710 in 1959.

**Ten Year Figures** 

The population of this district has increased almost a third in the last 10 years. There, were 43,039 residents in 1950. Growth in the six municipalities during this period is broken down as follows:-Park, 14,039 to 16,011; City, 6,445 to 6,827; Farms, 9,781 to 12,569; Woods, 10,109 to 12,120; Shores, 1,018 to 2,301 and Harper Woods, 1,772 to 6,762.

Residents of school age, five to 19 years, have increased from 9,873 in 1950 to 18,240 in 1960. Public school enrollment has increased from 5,585 in 1950 to 10.329 in the year which ended in June.

The City Manager was authorized to contract for the repair of catch basins at various locations in the City at a cost not to exceed \$1,000.00.

The City Engineer was authorized to issue building permits to Walter Mast. Inc., for the construction of resi-dences on the property located at the northeast corner of Charlevoix Avenue and McMillan Road.

On proper motion made, supported and carried, the meeting adjourned at 10:20 p.m.

## Most Everyone Goes To School

Those who think of our public school buildings as being structures used exclusively for educating our children, should be interested in an item which appears in the August report of Dr. James Bushong, superintendent of the Grosse Pointe Public School System.

Under the heading "Building Rental and Usage,' there is offered a summary of the number of hours the buildings have been used by non-public school groups during the past year and three preceding years. In 1956-57 the hours totaled 10,192. The following years. In 1990-ure jumped to 13,600 hours. In 1958-59 the buildings were used by such groups for 15,912 hours and the 1959-60 season saw them used for 15,304 hours.

Receipts for rentals, to cover operating expenses, wages, etc., amounted to \$15,651 for the 1959-60 year. During that period the buildings were used by some 70 outside groups including Boy and Girl Scout troops, square dance enthusiasts, religious organizations, many civic organizations and a multitude of other groups with water. varied interests.

There can be no question but that the entire community is deriving extensive year round use from the fine facilities which our school system provides, other than for the strictly academic purposes for which they were designated.
